In good and valuable consideration, for the payment of \$ \_\_\_\_\_, and for other valuable consideration, the receipt and sufficiency of which is hereby acknowledged, I hereby agree to the following terms in regards to the adoption of the above described Animal:

1. By undertaking to adopt the above said Animal, I agree to be fully responsible for the safety and well being of this Animal, and employ reasonable and due care to ensure its welfare at all times. I will be responsible for routine vet care, emergency medical care if necessary, food and all other care for the well-being of this Animal. I also warrant that I shall never use any type of electronic collar on this dog, or electronic fencing methods at any time.
2. I undertake not to leave this dog on a chain outdoors, in a garage, or within an unattended lot. This dog will never be used as a guard dog or for any illegal or illicit purposes. I agree to never subject this dog to physical or emotional abuse or cause it any harm prohibited under the various Canadian Animal Welfare legislation.
3. I undertake to notify Pit Bulls for Life if I can no longer care for said animal, and agree to give Pit Bulls for Life first option to take back the Animal for purposes of re-adoption. I will insure that this dog receives training as per the recommendations of Pit Bulls for Life. I also promise that

this animal will never be kept outdoors 24 hours a day and will have appropriate City licensing at all times.

4. I agree to pay an adoption fee of \$ \_\_\_\_\_ and am aware that I have 14 days to return the above said dog for a full refund.
5. I undertake to never alter the appearance of the above said Animal unless deemed a medical necessity by a Veterinarian.
6. I will grant a Pit Bulls for Life Representative admission to my home, with notice, two times within the first year of adoption and once in the second year if requested to follow up and reevaluate the above said Animal in my home.
7. I understand that if the terms of this contract are not followed to the satisfaction of Pit Bulls for Life this contract would be rendered null and void and would allow Pit Bulls for Life the right to demand the immediate return of said Animal.

RELEASE:

I do hereby remise, release and forever discharge **Pit Bulls for Life**, their heirs, executors, administrators, shareholders and assigns, of and from any and all manner action, cause of action, suits, debts, dues, sums of money, claims and demands whatsoever at law or in equity which I ever had, nor now have, of which I, or my heirs, executors, administrators or assigns hereafter can, shall or may have by reason of any matter, cause or thing whatsoever existing up to the present time, and without limitation, all matters relating to the adoption of said Animal and any unknown and unforeseeable damage or injury resulting from my adoption, ownership, care and control of this dog.

This Agreement shall be construed in accordance with the laws of the Province of Alberta.
